

Record received.</p> <p>Accused/petitioner namely <b>Murtaza son of Noor Khan</b>, resident of Qom Mishti, Tappa Haider Khel, District Orakzai, seeks his post arrest bail in case FIR No. 63, dated: 16.10.2024 under sections 379/427/147/149 Pakistan Panel Code registered at Police Station Mishti Mela, District Orakzai.</p> <p>Learned counsel for accused/petitioner heard.</p> <p>Brief facts of the case are that the complainant previously lodged instant FIR against the present accused/petitioner alongwith co-accused for cutting the crops of the complainant by force and took the same with their self.</p> <p>Perusal of record would reveal that source of information regarding involvement of accused/petitioner in the commission of the offence has not been disclosed by the complainant. Nothing incriminating has been recovered from possession of the accused/petitioner. There is an unexplained delay in the time of occurrence and lodging of report with the local police. 
