Accused/petitioner through Mr. Sana Ullah Khan  
Advocate present.

(2). Accused/petitioner, Muhammad Saeed s/o  
Muhammad Nazir, Caste Shalobar Khel, Village  
Maidan, District Khyber is seeking his post arrest bail  
in case FIR no. 01, dated 08.01.2025 u/s 9(d)CNSA of  
police station Dabori.

(3). Facts of the case as per contents of FIR are that  
complainant Muhammad Ishaq Khan SHO PS Dabori  
sent Murasila to the PS that on 08.01.2025 at 1940  
hours, he along with other police constables were  
present on barricade, at the place of occurrence main  
road from Arhanga to Dabori. In the meanwhile,  
motorcycle bearing registration no. FB 4566 black  
colour Honda-125 CC, Engine No. 3789538, Chassis  
No. 471839 coming from Arhanga side was stopped for  
checking and during search one packet Chars, wrapped  
in yellow scotch tape were recovered from under the  
seat, which were weighed through digital scale and

found to be 1229 grams. 10 grams from the same were separated for the purpose of chemical analysis and sealed into parcel no. 1 while the remaining 1219 grams were sealed into parcel no. 2. Video of the occurrence could not be prepared due to prevailing darkness at night. The accused disclosed his names as Muhammad Saeed s/o Muhammad Nazir and hence, the instant FIR.

Arguments heard and available record perused which shows that video of the occurrence has not been prepared despite of the fact that the same is mandatory provision under the law. There is no FSL report on the case file, despite of lapse of 06/07 days to show that the recovered articles was Chars which makes the case of accused/petitioner is one of further inquiry. I therefore, accept the instant bail application. The accused be resealed on bail subject to furnish bail bonds worth Rs. 100,000/ with two sureties local, relievable and men of means to the satisfaction of this court.

5. Copy of this order be placed on Judicial file while requisitioned record be returned to the quarter concerned while. Record of this court be consigned to Record Room after it necessary completion and compilation.
