



Order 15	21.12.2024	<p>Parties present.</p> <p>Vide this order this Court intends to dispose of instant application for grant of temporary injunction filed by plaintiff, hereinafter referred as the petitioner.</p> <p>Arguments heard and record perused.</p> <p>Now on perusal of the record and valuable assistances of both the learned counsels for the parties, petitioner through instant suit allege that he is the owner in possession of the suit property which consists of one kanal, fully detailed in the headnote of the plaint. He further alleges that he got approved a government water supply scheme in the year of 1997-98 from the stream known as Panjtan Pak Channa, from which water is supplied through pipeline to the people of different villages. Petitioner further alleges that he was employed by the government for this scheme and has completed the job on the same and now his son is in service of the government on the same water supply scheme. Hence, respondents have got no right to interfere with the suit property or to claim their ownership over the same or change its nature or to cut the pipe line of the government scheme. Contrary to this respondents allege that they are owners in possession of the suit property since the time of their predecessors. They further allege that the water scheme was approved by a government department and petitioner have no concern with the same.</p> <p>For above discussion, this Court is of the view that the respective stance alleged by both the parties to the suit is subject to proof after recording of pro and contra evidence and furthermore, in absence of revenue record in district Orakzai, at this stage it is not possible for this court to</p>

Continued Order 15	21.12.2024	<p>ascertain that as who amongst the parties to the suit is real owner of the suit property. However, in order to preserve the suit property from alienation or from changing its nature during the pendency of instant suit or disturbing the government water supply scheme, which is utmost public utility, this court deem it appropriate to restrain respondents to this effect.</p> <p>In light of above discussion, instant application for grant of temporary injunction filed by plaintiff is hereby <b>allowed</b> and temporary injunction for the statutory period of six months or till disposal of instant suit, whichever comes earlier, is hereby granted in favour of plaintiff and defendants are hereby directed to restrain from alienation of suit property through any mode of transfer or to change its nature and restrain from the interference with the suit property and the water supply scheme. No order as to costs.
