





The above-named accused/petitioner seeks confirmation of his ad-interim pre-arrest bail in case FIR no. 63, Dated 22.11.2024, u/s 379/427/147/149 PPC registered at Police Station Mishti Mela, wherein, as per contents of FIR, the complainant on 10.11.2024 at 0900 hours vide Daily Diary No. 09 made a report to the local police to the fact that he belongs to caste Mishti Tapa Darwi Khel and owns agricultural land comprising four fields. The accused/petitioner along with co-accused on 16.10.2024 have forcefully harvested and have taken it. In this respect, he made a report to the local police who intervened and restrained the accused/petitioner and co-accused; however, after the police left, they continued to cut and remove the crops. Contin. Order No.03		<p>the SHO of Police Station Mishti Mela and the accused/petitioner along with co-accused have been charged in the instant FIR.</p> <p>(3). Arguments heard and record perused.</p> <p>(4). Perusal of the case file reveals that there seems to be a civil dispute between the parties and the accused/petitioner prior to the instant FIR, has been charged in two other FIRs as well; therefore, false implication cannot be ruled out. The accused/petitioner have already joined the investigation and he is no more required for further investigation besides nothing is to be recovered from his possession as such the recalling of bail for observing certain codal formalities would not be justifiable. The prosecution has failed to elucidate the consequential purpose that would be served by committing the accused/petitioner to police custody.</p> <p>(5). Therefore, in the light of above, the BBA in hand stands accepted and ad-interim pre-arrest bail earlier granted to the accused/petitioner stands confirmed on the strength of existing bail bonds.</p> <p>(6).
