That for resolving the said dispute today on 31.01.2021 SP investigation, **DSPs** namely Lower, Orakzai ACMuhammad Rahim, Umar Zaman and Mehboob Khan convened a jirga with the elders of all the five castes. First jirga was convened with the elders of caste Akhel namely Qasim Gul, Fazal Muhammad, Muhammad Rehman, Lal Zad, Haji Tahir, Abdul Razaq, Anwar, Molana Umar, Khanan, Naseem Gul, Sailal Shah, Hazrat Khan, Khaista Meer Shah, Umar Badshah, Hafiz Ullah, Azmat Ullah, Muhammad Sajid and 8/9 others. After that Jirga took place with the elders of caste Mishti namely Musa Khan, Khan Zeb Ullah, Ameen Ullah, Piyo Shah, Saleem Khan, Itbar Gul, Haji Munaf, Rasool Badshah and 7/8 other persons. Jirga with elders of caste Shiekhan, namely Haji Kareem, Shafiq Khan, Toor Haji, Mastan Akbar alias Mastak, Haji Izat Gul, Suwab Gul, Firdos, Taza Khan,

During interval of prayer in the jirga the people of the caste Mishti, Shiekhan, Dara Dar Mamozai and Rabia Khel along with other 200/250 persons were instigated, who attacked at the disputed rooms. The police officials present in the rooms shown resistance to restrained them, but they attacked the police and put on fire the luggage of the police and demolished the rooms. Apart from this Qasim Gul etc and other persons mentioned above brought 30/40 armed men, who started firing at the police party and people of other castes with intention to kill. The exchange of firing took place from both sides and due to the firing of caste Akhel two (2) persons of the opposite castes died and three (3) got injured. The dead bodies and injured were sent to THQ

that more than 60 accused are charged in the instant case. That there was dispute between the different sections (Aqwam) of Orakzai and it cannot be determined that who attacked the disputed property and committed murders. Neither specific role is attributed to any of the accused for burning the disputed property, nor any role for making firing is attributed to any of the accused/petitioners. He argued that there is no direct evidence against any of the accused/petitioners on the case file. That statements of fourteen PWs have been recorded and the same are of no worth to the prosecution

(9). On the other hand, learned Sr. PP for the state argued that the accused are directly charged in the FIR for unlawful assembly, putting the property on fire, murder and attempt to commit murder. He argued that

After hearing arguments available record perused. It is the case of prosecution that some days back Qasim Gul caste Akhel along with other people of his caste constructed two rooms on the disputed property situated at Mula Patey due to which the people of other castes i.e., Misthi, Rabia Khel, Shiekhan and Dara Dar Mamozai were desperate and unhappy. That the said dispute was likely to convert into clash, for resolving which Jirga of Mashran of the all the five castes was convened by SP investigation, AC Lower and DSPs. That during prayer break in the Jirga more than 200 people of caste Mishti, Shiekhan, Dara Dar Mamozai and Rabia Khel attacked the disputed rooms. They were restrained by the police party present in the rooms, by they were attacked upon, put on fire the luggage of the police officials and demolished the disputed rooms. On the other hand, about 30/40 people of Qasim Gul Akhel, District & Sessions Judge-1

duly armed came, attacked the police party and people of other castes by making firing with intention to kill. That exchange of fire took place between the parties and due to firing of caste Akhel two persons of rival castes were killed and three injured. The statement of complainant

Muhammad Naseem SHO is recorded as PW-14, who repeated the same story, as alleged in the Murasila, during his examination in-chief. He stated during his cross examination that during Jirga i.e. 1330 hours to 1500 hours the occurrence took place and it is not mentioned in Murasila that who was carrying weapons, who made firing and who sit the disputed rooms on fire. PW-14 admitted that has not shown the specific point of presence of accused to the investigation officer at the time of preparation of site plan. He further explained that he cannot say that from whose firing shot the deceased and injured got hit and that the firing had taken place from both sides. The witness during his volunteer statement explained that due to firing of caste Akhel two persons got hit and expired while three got injured. Investigation officer Bakht Munir/PW-9 during his cross examination admitted that no specific person from the tribe Akhel is named in the Murasila, who was involved in firing. He admitted that he did not specifically investigate the fact that which tribe was involved in firing and accordingly to police report all the tribes were present there and made firing over the police check post. He further stated that the place of occurrence is open rivel (algada) and there are ups and down in the said algada, due to which a person cannot be visible from 100 feet. He also stated that tribe Akhel was present at the

distance of 1348 feet from the other tribe present over there. The statement of PW-9 and PW-14/complainant who was present there at the time occurrence, shows that in fact no one have seen anything and that responsibility of making firing and hitting the deceased and injured is neither fixed by the complainant during his report nor determined by the investigation officer during his investigation. In fact the instant FIR is inspired from the FCR where the people of whole caste/tribe had have been held jointly liable for commission of an offense. In the present FIR the whole tribe of Akhel is made accused, but none of the witnesses could explain that the deaths and injuries happened due to firing of Akhel tribe rather it is established on record from the statements of PWs that the firing was made by all the tribes and the same cannot be attributed to a specific person. No recovery of any weapon has been effected from any of the accused facing trial or even from the possession the

absconding accused. In such like circumstances, there is

trial and absconding accused, therefore, I hereby accepted the instant application u/s 265-K Cr. PC. and acquit all the accused facing trial along with absconding accused from the charges levelled against them. The accused are on bail and their sureties are discharged from the liability of their bail bonds. Case property i.e.,
