Screening Test for the post of AD&SJs to be held on 25.01.2025 at Peshawar High Court Peshawar

General Instructions

- The candidates shall report at the Examination Centre (**Peshawar High Court Building, Peshawar**) by **09:00 am.** for the purpose of **Registration etc.**
- Screening test shall commence at **10:00 am.**
- Duration of screening test shall be **100 minutes.**
- No candidate shall be allowed entry in the examination hall after the commencement of screening test.
- No candidate shall be admitted to examination hall unless he produces **Original CNIC, Roll No. Slip** and **Original Challan Receipt** of fee paid by him for the screening test.
- Do not bring any electronic devices or gadgets including mobile phones and smart watches to the examination hall. If any candidate is found in possession of any such device, it may be confiscated and his paper may be cancelled.

Special Instructions:

- The candidates shall write their Name, Father's Name, Cell Number, Roll Number clearly and put their Signature on the question paper/answer sheet at the **specified place.**
- Only the **correct option shall be Ticked (✓)** on the question paper/answer sheet by using ball pen (black or blue). No pencil or eraser shall be used.
- Marking/Ticking more than one option shall be considered as incorrect answer.
- Do not mark or write your answers anywhere else on the question paper/answer sheet except the specified place.
- No candidate shall remove or tear any page from question paper/answer sheet.
- The candidates shall not leave their seats or communicate with other candidates during the test.
- If any candidate has a question, he/she must raise his/her hand while sitting on the seat and wait for an invigilator.
- An announcement will be made 15 minutes before the end of the test.
- No candidate shall leave his/her seat until the invigilator has collected his/her paper.
- No candidate shall keep or use any material during the test which is not provided by the Examiner/Invigilator.
- At the end of the test, the candidates shall return the Question Paper to the invigilator.

Any violation of the above instructions may lead to cancellation of paper and disqualification of candidate.
