Formal charge against the accused facing trial was framed on 09.05.2024, to which they pleaded not guilty and claimed trial. Statements of DFC as SW-01, Shahjehan IO as PW-01 and complainant as PW-02 recorded.

On previous date notice u/s 249-A Cr.P.C was given to the prosecution. Arguments heard and record perused.

The perusal of record shows that as per report lodged by the complainant vide Naqalmad No. 08, Dated: 26.10.2023, the occurrence has taken place on 03.09.2023 at 11:00 hrs but the application to DPO Orakzai was written on 11.09.2023 and FIR was registered on 01.11.2023. There is a delay of 08 days between occurrence and application to DPO and also delay of about 02 months between occurrence and FIR.

Furthermore, there is no evidence about the mysterious informant, no material, circumstantial or ocular evidence. Alleged stolen items have not been recovered. Their proprietary status i.e. being owned by the complainant, is also not established on record.

Senior Civil Judge Orakzal a Raber Mela

The above make the instant trial an exercise in futility.

The court would be groping in the dark for an offence on which there is no human, or material evidence available.

I therefore, acquit the accused facing trial namely Zina Gul, Samin Badshah, Waris Khan, Khamin Akbar, Nasir Khan, Naimat Khan and Mina Din-from the charges levelled against them. They are on bail. Their sureties are discharged from the liability of bail bonds. Case property if any be kept intact till expiry of the period provided for the appeal/revision/writ etc.

Keeping in view the available record, this court is satisfied that a prima facie case exists against the
