Petitioner through special attorney and counsel present. Ex-parte arguments heard and record gone through.

Perusal of case file reveals that the instant petition is instituted by the petitioner namely **Mst. Rehmat Khela Wd/O Ashiq Khan** for her appointment as legal guardian for the person of the minors namely **Sohail Abbas aged about 15 year, Muhammad Zohaib aged about 08 years Ss/O Ashiq Khan, Mst. Shahnaz Bibi aged about 17 years and Mst. Kianat Bibi Ds/O of Ashiq Khan** mentioned in the petition on the grounds that the petitioner is the real mother of the minors and that father of minors has been died on 28.10.2022.

The respondents/general public were summoned through publication in newspaper "Daily Ausaf" dated: 24.11.2024, however none turned up as legal guardian of the minors other than the petitioner. Therefore, the respondents were proceeded against ex-parte. Consequently, petitioner produced ex-parte evidence.

During course of recording evidence, Wazir Akbar (special attorney) appeared and recorded his statement as PW-01. Said Habib and Shindi Gul deposed as PW-02 & PW-03 respectively. PW-01 produced special power

of attorney as Ex.PW-1/1, copy of his CNIC as Ex.PW-1/2, copy of death certificate of father of minors as Ex.PW-1/3, copy of form "B" of minors as Ex.PW-1/4, copy of CNIC of mother of minors as Ex.PW-1/5. Copies of CNICs of PW-02 and PW-03 are Ex.PW-2/1 and Ex.PW-3/1. Contents of the petition were reproduced and verified by the witnesses.

At this stage there seems to be no clash of interest between the minors and the petitioner, being the real mother of the minors, in the light of statements of witnesses produced by the petitioner, it is evident that minors are residing presently with the petitioner, who is looking after them. As a real mother, she is most likely to take care of the welfare of the minors. Therefore, the petition in hand is accepted under Section-07 of Guardian & Wards Act, 1890 and petitioner is appointed as guardian of the person of the minors namely **Sohail Abbas aged about 15 year, Muhammad Zohaib aged about 08 years Ss/O Ashiq Khan, Mst. Shahnaz Bibi aged about 17 years and Mst. Kianat Bibi Ds/O of Ashiq Khan** having generally the rights, duties and liabilities of a guardian mentioned in the Guardian & Wards Act, 1890 and subject to the following conditions especially in view of section-34 of the said Act.

- *That she will produce the minors in court as and when required by the court.*
- *That she will maintain and educate the minors in proper manner.*
- *That she will not act in prejudice to the interest of minors.*
- *That she will not be entitled to dispose of the property of minors*

*without prior permission of the court.*
