Petitioner present through counsel. Record received. Arguments heard and record perused.

This order of mine is intended to dispose of the instant misc. application for correction of name of Mst. Aqeela Jana in the Succession Certificate.

Per record petitioner Bahadar Khan etc were applied for Succession Certificate in their favor being the legal heirs of deceased Salim Khan. After recording of ex-parte evidence, Succession Certificate was issued by this court vide order dated: 28.07.2022 in favor of petitioners.

Petitioners contended that name of petitioner namely Mst. Aqeela Jana is mentioned as Mst. Akila Bibi in the Amended Succession Certificate. Petitioner requested for acceptance of application accordingly.

Seemingly, spelling variance has resulted in legal complications for the petitioners. Keeping in view the contents of application and available record, name of Mst. Aqeela Jana is entered correctly in the Amended Succession Certificate instead of Mst. Akila Bibi. Amended Succession Certificate be issued in favour of the petitioner on furnishing surety bonds/undertaking in the sum of Rs: 500,000/- (five lac) with two local & reliable sureties each in the like amount to the satisfaction of this Court

within 10 days.

Court allowed his application subject to filing of an undertaking about the loss of the certification.
