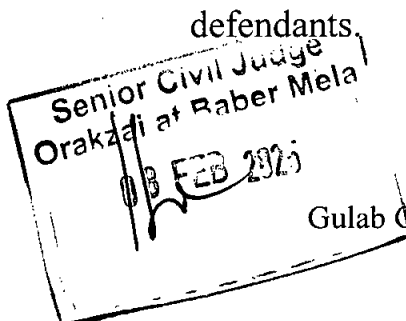
SUIT FOR DECLARATION & PERMANENT INJUNCTION

EX-PARTE JUDGMENT

08.02.2025

This judgment decides instant case filed by Mr. Gulab
Gul for correction of names of his parents as maintained by the

defendants.



Pleadings:

The claim as related in the plaint reads that correct name of the father of the plaintiff is Mr. Sawab Gul and that of her mother is Mst. Khwaga Jana while the defendants have wrongly entered the same as Mr. Masti Gul and Mst. Bismillah Jana respectively. It is alleged that when defendants were requested to rectify the mistake extra-judicially, they declined, hence the suit.

Defendants were summoned through the process of the court but no one appeared on their behalf; hence, they were placed and proceeded ex-parte.

Thereafter, plaintiff was invited to produce his ex-parte evidence to establish the position he had taken in his pleadings.

Gulab Gul, the plaintiff himself appeared as PW-01, Mian Gul s/o Masti Gul appeared as PW-02 and Khujal Khan s/o Nazar Khan as PW-3. They have exhibited the following documents;

Reasons/Reasoning:

Mr. Gulab Gul, the plaintiff himself, took the stand as PW-01. He narrated the same story as in his plaint and requested for the decree as prayed for.

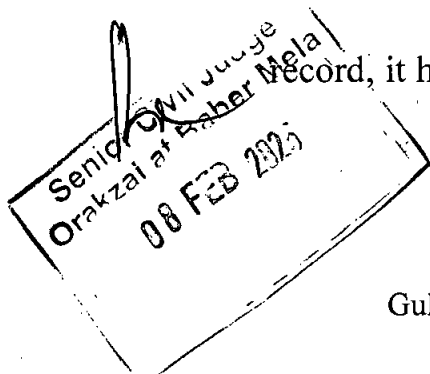
Mian Gul s/o Masti Gul, took the stand as PW-02 who supported the stance of the plaintiff.

Conversely, Khujal Khan s/o Nazar Khan took the stand as PW-03, he also supported the claim of the plaintiff.

I have heard ex-parte arguments of the learned counsel for the plaintiff and have perused the record. Apparently, at the time of registration with defendants, uncle and aunt were shown as the parents of plaintiff. Mr. Masti Gul and Mst. Bismillah Jana are uncle and aunt of the plaintiff. Their son, Mr. Mian Gul has confirmed these facts.

Further, siblings of the plaintiff from the parentage claimed in the suit were summoned as court witnesses on 08/02/25. Mr. Aamir Khan, Mr. Muhammad Aieen and Mr. Nawar Khan appeared and recorded their statement to concede the claim of the plaintiff that he is their real brother.

After hearing of ex-parte arguments and perusal of the record, it has been established that parents' names of the plaintiff



have been wrongly entered by the defendants; therefore, suit of the plaintiff is hereby ex-parte decreed in his favor against the defendants as prayed for. *The correct name of the father of the plaintiff is declared as Mr. Sawab Gul and that of his mother is Mst. Khwaga Jana (خواگہ جانہ)*. Defendants are advised to bring their records in line with this judgment. Costs shall follow the event.
