Sr. PP, Abul Qasim for the state present. Aftab Hassan IO present and his statement recorded as PW-01.

Facts of the case as per contents of Murasila are that the local police were present for patrolling in the area of Khazay Mord, Anjani, in the meanwhile a motorcycle boarded by two persons having in possession of a blue colour sack and upon seeing the local police, they left motorcycle and made their escape good in mountains. Upon checking the sack, 50 packets chars wrapped in yellow scotch tape were recovered. Each packet were weighed through digital scale which came out to be 1000grams making the total of 50000 grams. 10 grams from each packet were separated through sharp object and packed and sealed into parcel No. 1 to 50 out of which 25 packets having 24750 grams chars were packed and sealed into parcel No. 51, while remaining 25 packets chars having 24750 grams chars were packed and sealed into parcel No. 52. Blue colour sack was sealed into parcel No. 53. Video of the occurrence was prepared through mobile phone and converted into USB sealed the same

into parcel No. 54. All the parcels were affixed with the 3/3 seal monogram of "MY", while one stamp of the same monogram was put inside each parcel. Motorcycle Honda 125cc in red colour, bearing No. 4125, Peshawar, engine number 7526595, chassis number U708783 was taken into possession vide recovery memo and FIR against unknown accused was registered.

- After registration of the case against unknown accused, investigation was conducted, however, nothing fruitful could came out as actual culprit has not been traced out and to this effect statement of IO was recorded wherein, he stated that he tried his best to trace the real culprits involved in the occurrence, but the same could not be traced yet.
 - In view of the above, the SHO concerned and IO are directed to make fruitful efforts to trace out real culprits. The case in hand be filed without further proceeding being "untraced". Copy of this order along with judicial file be sent to the SHO PS concerned with directions to keep the same in "Basta 5 Sala" of the PS and resubmit the same after tracing the real culprits. Case property be kept intact till further orders while record of this court be consigned to the record room after its further necessary completion and compilation.

Stated on oath that I have conducted investigation in the instant case. PW1/1 and duly signed by me. Similarly, I have sent parcel no. 54 to FSL vide application dated 29.08.2024 which is Ex. PW 1/2 and transit receipt No. 148/21-K dated 29.08.2024 through constable Sajid Khan no. 330 which is Ex. PW 1/3. Similarly, I have sent parcels no. 1 to 50 vide application dated 29.08.2024 which is Ex. PW 1/4 and transit receipt No. 147/21-K dated 29.08.2024 is Ex. PW1/5 through constable Sajid Ullah No. 330 to FSL. Which all correctly bears my signature. The FSL report was received which is Ex. PW 1/6. During investigation I tried my best to tracethe real culprits involved in the occurrence, but the same could not be traced as yet. At the expiry of statuary period, I sent the case file for submission of challan against the unknown accused. I am still the Incharge Investigation at PS Kalaya and trying to trace the real culprits, but I have not succussed to trace them as yet.
