> Sr. PP, Abul Qasim for the state present. Muhammad Hanif OII present and his statement recorded as PW-01.

> Facts of the case as per contents of Murasila are that on 21.08.2024 at 1800 hours, Akhter Munir SHO along with constables Faheem Asghar No. 1286, Shamir Ullah No. 2195 along with driver Sami Ul Haq No. 1349 were on patrolling on Main Road Mishti Mela, in the meanwhile a motorcycle boarded by one person coming from Mishti Bazar side having in possession of a sack on rear seat of motorcycle fixed by rope and upon seeing the local police, he take Uturn but at some distance motorcycle driver left the motorcycle and make his escape good in nearby areas. Upon checking the sack, chars were recovered, and weighing through digital scale which came out to be 20000-gram chars. 10-gram chars were separated from sack for FSL which was packed and sealed into parcel No. 01, while remaining 19990 grams chars wrapped in yellow colour sack were packed and sealed into parcel No. 02. Video of the occurrence was prepared through mobile phone and converted into USB sealed

the same into parcel No. 03. All the parcels were affixed with the 3/3 seal monogram of "AR", while one stamp of the same monogram was put inside each parcel. Motorcycle Honda 125cc in black colour, engine number R023796, chassis number EA705986 was taken into possession vide recovery memo and FIR against unknown accused was registered.

- 3. After registration of the case against unknown accused, investigation was conducted, however, nothing fruitful could came out as actual culprit has not been traced out and to this effect statement of OII was recorded wherein, he stated that he tried his best to trace the real culprits involved in the occurrence, but the same could not be traced yet.
 - In view of the above, the SHO concerned and IO are directed to make fruitful efforts to trace out real culprits. The case in hand be filed without further proceeding being "untraced". Copy of this order along with judicial file be sent to the SHO PS concerned with directions to keep the same in "Basta 5 Sala" of the PS and resubmit the same after tracing the real culprits. Case property be kept intact till further orders while record of this court be consigned to the record room after its further necessary completion and compilation.
