ORDER

DPP, Umar Niaz for the State and Khursheed Alam Advocate for accused/petitioners present. Record received. Complainant Qasid Ali present in person.

2. At the very outset, the complainant Qasid Ali stated at the bar that he has patched up the matter with the accused/petitioners out of the court, forgiven them in the name of Almighty Allah and has got no objection upon the release of accused/petitioners on bail or upon their acquittal. To that effect, his statement recorded and placed on file.

3. The accused/petitioners, **Ijad Ali** s/o Surat Ali and Ajmeen Ali son of Habib Ali seek their post arrest bail in case FIR no. 08, dated 15.03.2022, u/s 436/427 PPC of Police Station Kurez Boya, wherein as per contents of FIR, on 13.03.2022 at about 0015 hours a veranda constructed by him on his own expenses, adjacent

to the common hujra of the village, caught fire causing damage to the articles in the veranda besides damaging the roof of veranda. That after due inquiry and satisfaction, he has come to know that the veranda has been put to fire by the present accused/petitioners and other co-accused named in the FIR on the pretext of their claim over the hujra. Hence, the present FIR.

4. Arguments heard and record perused.
5. Perusal of the case file shows that though the accused/petitioners are directly charged but there is no eye-witness of the occurrence. As per affidavit coupled with statement of the complainant, he has got no objection upon the release of accused/petitioners on bail. Hence, the accused/petitioners are admitted to the concession of bail subject to the conditions of affidavit Ex. PA, provided he submits two surety bonds in the sum of Rs. 80,000/- with two sureties, each in the like amount to the satisfaction of this court. The sureties must be local, reliable and men of means.
6. Order announced. File of this court be consigned to record room after its necessary completion and compilation.
